2. Extent in delegating statutory work (See Note 2):

"F" : Full authorization to perform plan review, carry out surveys/audits and issue necessary certificates relative to the above mentioned IMO Conventions;

"P" : Partial authorization;

- 1) to perform plan review and carry out surveys/audits where the Administration issues the necessary certificates; and/or
- 2) to perform plan review, carry out surveys/audits and issue necessary

certificates for less than the full complement of certification for each of the Conventions.

- 3) the authorisation is limited for certain types of ships, and/or
- 4) the authorisation is subject to geographic limitations.
